To obtain official recognition of the ECDL National Agency.

Work report

(including working techniques used, results and methodology)

A contract has been signed with the ECDL Romania – the ECDL National Agency in Romania. Consequently, the **CECA** centre is **THE FIRST** centre accredited in Romania that can provide training/testing in **ECDL CAD**. In order for the centre to be accredited, two certified lecturers (instructors) were needed. Pending an 4 hours examination by ECDL Romania staff members, Mr. Vlad Ionut Paun and Mr. Catalin Gheorghe Amza successfully received the official recognition. Furthermore, steps were taken in order to have a third ECDL instructor in the structure of the CECA centre in the person of Radu Constantin. Following procedures drafting and understanding, ECDL Romania performed an audit of the centre through Mr. Vlad Cazan.

Deliverables

The official accreditation of the CECA training/testing for ECDL CAD. This will allow the newly founded centre to be able to provide the students at the end of their course with ECDL official diplomas pending an official examination/testing.
